Mr. Vaughn Alan Mullet, 74, of Newnan, GA, formerly of Mansfield, Ohio, passed away on Sunday, July 21, 2024 at Piedmont Newnan, Hospital. He was born July 4, 1950 in Mansfield, Ohio to the late Carl Mullet & Janeith Merrill Mullet.

“ This is Dave and Flo Ireland

*Our memories of Vaughn and Nancy go back to around 1975, they were meeting with the missionaries (investigating) THE CHURCH OF JESUS CHRIST of LATTER-DAY SAINTS. At that time Ron Curnutt was the Elders Quorum President in the Mansfield, Ohio ward. I was Ron's 1st councilor, and we held a Halloween party in a barn of a members home just outside of Mansfield. Vaughn and Nancy were not members yet, we had a blast, we were all in our late 20's and enjoyed every moment we had together.*

*Vaughn and Nancy were baptized and became members of THE CHURCH OF JESUS CHRIST of LATTER DAY-SAINTS. About six months ago (January 2024) I was able to locate Vaughn's cell phone number; I called him, and we had a great visit. He told me that he and Nancy were still very active in the church and loved their time in the temple. I told Vaughn how grateful I was for he and Nancy's friendship; I also told him that it reminded me the story in the Book of Mormon where the sons of Mosiah had met up with Alma the younger on the road to Zarahemla, and how great their joy was to find that they were all still loyal to the Savior and active in his church after all these years.*

*I also remember a time when Vaughn and Nancy, went with Flo and I to their first stake conference in Columbus, Ohio. Spending time with Vaughn and Nancy was always a dream come true.*

*In January 1978 Vaughn was a District Sales Manager for Warren Rupp Pumps (WRP) in Mansfield, Ohio. I (or rather Flo sent in my resume) responded to an employment add in the Mansfield News Journal for an inside salesperson at WRP. I was hired in January 1978. I did not tell Vaughn I had applied for the position and when I saw him at church the next Sunday, he said to me "why didn't you let me know I would have put in a good word for you". That was Vaughn always looking out for others and supporting them. I got the job and four months later I joined Vaughn as a DSM for WRP only I*

would be in California.

*After I was made a DSM at WRP, I no longer had an office at WRP because I was now considered an outside salesperson. Vaughn took me under his wing and allowed me to travel with him to Michigan, Pennsylvania, Ohio, and other places; training me on what a DSM does. I truly enjoyed those times together, learning from Vaughn and his vast experience in the pump industry. He became one of my best friends on this earth.*

*When it became public that Flo, Kim, Heidi, and I were moving to California; Vaughn and Nancy held a going away party for us at their home. They invited everyone for WRP and the Mansfield Ward. Thank you, Vaughn, and Nancy for a great time and a great memory.*
